**SUBJECT:** TAM Crossing Guard Program Location Recertification (Action), Agenda Item No. 8

#### RECOMMENDATION

The TAM Board take the following actions:

- 1. Adopt the Ranked List of Crossing Guard Locations shown in Attachment A;
- 2. Adopt the funding level for the 2018/2019 school year to extend to Rank 58;
- 3. Support allocating \$170,000 of Vehicle Registration Fee carryover to fund 18 locations from August to December should the Transportation Sales Tax Renewal be placed on the November 18 ballot.

The TAM Programming and Projects Executive Committee unanimously recommended the actions at their meeting of March 12<sup>th</sup>, 2018. There was strong support for all three items. When considering using rollover funds from the VRF, committee members supported crossing guards as a priority safety element of the VRF Program. There was a request for further discussion regarding the long-term plan for unused funds associated with Element 3 of the Vehicle Registration Fee. Staff will bring this discussion forward in April to the TAM Board.

#### BACKGROUND

The TAM Crossing Guard Program provides trained crossing guards for critical intersections throughout Marin County. As committed in the Transportation Sales Tax (Measure A) Expenditure Plan, the Program uses trained crossing guards under contract to a professional company that specializes in crossing guard programs. The 2017/2018 school year is the twelfth year during which crossing guards have been funded by the TAM Crossing Guard Program. TAM also has an agreement with several school districts to provide additional guards on a reimbursed basis.

Measure A requires that the Crossing Guard Program be assessed periodically and that locations eligible for funding through the TAM Crossing Guard Program be prioritized by Public Works Directors together with the Technical Advisory Committee, and be approved by the TAM Board. The process for establishing a ranked list to be used for prioritizing the locations is referred to as the "recertification process."

The Crossing Guard Program is currently funded by a combination of the ½ cent Transportation Sales Tax (Measure A), the Vehicle Registration Fee (Measure B), Safe Routes funds from the Metropolitan Transportation Commission, and direct payments from various School Districts. There are currently 150 locations on the master list, of which, 90 have an assigned crossing guard. Eight locations of the total 90 are funded completely by various school districts including Novato Unified, Kentfield, Larkspur-Corte Madera, Dixie, and the Mark Day School.

The methods employed for data collection, analysis and location scoring for the 2017 recertification process were reviewed and approved by the Marin Public Works Association (MPWA), TAM Technical Advisory Committee (TAC) and TAM Board at the June 22, 2017 meeting. Details about the recertification and scoring process were provided to the Board at the January 25, 2018. TAM Board Meeting. The process involves scoring each crosswalk of an intersection separately, for each day of counts. It is estimated that approximately 500 crosswalks were evaluated for each of over two days' worth of data.

In order to reduce the expenditures for evaluating all 150 sites, a process was approved in June that allowed for some intersections to be "carried over" to the top of the new ranked list based on their consistent high ranking in the previous two recertification cycles, and for some locations to remain at the bottom of the ranked list based on their consistent low ranking in the previous two recertification cycles. A total of twenty-eight (28) locations were included in both groups: seventeen (17) in the top tier group; and eleven (11) in the bottom tier. Local jurisdictions were given the option of having data collected for any location in either of the groups and being included in the 2017 recertification scoring process regardless of the ranking history. Two locations were added back in from the eleven in the bottom tier group and included in the scoring process, i.e. data was collected and they were scored with the others.

#### **DISCUSSION/ANALYSIS**

The TAM TAC recommended approval of the attached ranked list at their March 15 meeting. Some concern has been raised that the methodology did not include sufficient analysis of accident history at the crossing guard locations. It was pointed out by TAM staff that the decision to not perform a full engineering analysis at all 150 sites was made at the beginning of the program. This decision was based on placing as many guards in the field as possible. Most members of the recertification team from public works around the county confirmed it prudent at this time to stay with the adopted approach.

Approval of the recommended action would result in a new ranking of the 150 candidate crossing guard locations on the master list which would be used as the basis for determining which locations are eligible for funding through the TAM Crossing Guard Program until the next recertification cycle expected to occur in four years. Meetings have occurred with public works departments and school district staff to go over individual sites that either moved up or down in rank location as compared to the current list (prepared and approved in 2014).

Staff recommendation is to approve funding on the Ranked List to Rank 58 for reasons discussed below, under Fiscal Consideration. Projections show that this level can be maintained until the sunset of the current Transportation Sales Tax in 2024. Attachment B shows in which School Districts the 58 guards would be assigned. Attachment B also shows the impacts on existing guard locations that would not be returning with the new list and recommended level of ranking. There are actually 35 locations that currently have a guard, that are not shown to be funded by the Marin Program next year. Note, 35 locations are three more than the 32 shown in Attachment A, since three locations are above Rank 58 that are not currently guarded. Some of the 35 locations will be guarded by school districts funding the cost of the location. Novato Unified School District has already notified TAM staff that it is highly probably that NUSD will fund 4 locations next year.

TAM staff is continuing to meet with each school district to determine if they would like contribute 100% of the cost of a guard or participate in the Volunteer Crossing Guard Program at an expected cost of approximately \$5,000 per year as long as a volunteer is available. Guard cost is expected to be approximately \$17,300 for next year. This does not include TAM Program Management which is provided at no cost to our partners.

The TAM Programming and Projects Executive Committee discussed this item at their March 12 meeting. There was strong support for all three items with many comments expressed about supporting the safety elements of the Program. There was a request for further discussion regarding the long term plan for unused funds associated with Element 3 of the Vehicle Registration Fee.

#### FISCAL CONSIDERATION

### Level of Crossing Guards must match available revenue

Based on current revenue projections and cost forecasts, the number of locations to be funded through the Program for the 2018/2019 regular school year and beyond will be reduced. Current projections indicate that current funding will only be sufficient for 58 guards starting in August 2018. The large reduction is due to overfunding new guards between recertification cycles without a reduction near the end of the list, and temporary grant funding that is disappearing. This ranked list established during the 2017 recertification process will serve as the basis for determining which locations are eligible for funding from the TAM Crossing Guard Program for the 2018/2019 school year.

Currently eight locations are funded directly by school districts. Novato Unified has indicated they will probably continue to fund four locations. Mark Day School has indicated that they will most likely discontinue funding the location at Arias Street and Trellis Drive (Rank 123). The remaining three sites are funded one each by Larkspur-Corte Madera, Dixie, and Kentfield School Districts. Staff at TAM will continue to communicate with each District to determine if they wish to continue.

Attachment C shows the impact to all schools currently served by the Program. Many schools are losing all or many of the guards that serve that location.

## The Draft Expenditure Plan for sales tax renewal adds funds and prevents cuts

Adding funds to the Crossing Guard program in a renewal of the sales tax was adopted by the Expenditure Plan Committee (EPAC) as part of the plan for renewal of the Tax. The EPAC proposal for crossing guards is recommended to increase from 4.2% to 6.5% of the Sales Tax.

A projection was made utilizing 6.5% of the Transportation Sales Tax as well as keeping the existing percentage of the Vehicle Registration Fee. It is expected that the baseline for guard funding would extend down to Rank 88.

## Staff recommends funding be increased out of TAM's VRF until December 2018

It is uncertain at this time if the Sales Tax renewal will be placed on the ballot in August for the November election. If it is placed on the ballot and passed, then the percentage increase of funds to guards prevents cuts. Staff is concerned that the 20 current guards that are between Rank 58 and 88 should not be discontinued in August 2018 if the Transportation Sales Tax Renewal is placed on the November 2018 Ballot, and perhaps passes.

Should the ballot measure pass, the Program would have discontinued 20 guards in August only to reestablish them in January. For this reason, TAM staff is recommending allocating \$170,000 of Vehicle Registration Fee carryover to fund the 20 guard locations from August to December. This action would leave approximately \$1 million in excess funds still remaining in the VRF Element 3 account, for the Board to decide to allocate to other needs. This action would only be implemented if the Sales Tax renewal is placed on the November ballot in August, otherwise the 20 locations would be discontinued before school begins.

Note, ten of the locations between Rank 58 and Rank 88 are new locations without a current guard. These ten locations would not be guarded until after the Transportation Sales Tax is renewed with an increased percentage to crossing guards (and of course only if the Board decides to pursue those actions).

#### **NEXT STEPS**

Staff will continue to meet with school district staff to determine if any additional sites will be paid for (either full cost or volunteer program) by the districts. Many school districts are in the process of preparing their 2018/2019 budgets at this time and are trying to decide if sufficient budget exists to fund crossing guards.

Staff in April and May will notify the users of the locations that will not be continuing guard service beginning next Fall. The noticing will include coordination with the school administrative staff and direct leaflet distribution. This notification will occur prior to the end of this current school year, and repeated at the beginning of the 2018/2019 school year in the Fall. Messaging will be different for those sites that are between Rank 58 and Rank 88, and also those sites that school districts have indicated that they may fund. The message will indicate that the sites <u>may</u> be eliminated unless the sales tax renewal is placed on the ballot, and is approved by the public.

The message for the sites below Rank 88 and where the school district has indicated that they are not planning to possibly fund will get message indicating that the site has been discontinued. For the initial notification it is expected there will be a limited number of these existing locations, probably around five.

Staff is always exploring additional grant opportunities to fund crossing guards. In the last four years, TAM has been able to secure \$188,000 in one time funding for crossing guards.
