
Ms. Hogaboom, I think you should not eliminate the crossing guards. They keep cars moving and keep us safe.

Accident victim facing lengthy recovery

The condition of a young Novato mother severely injured when she was struck walking in a crosswalk on S. Novato Boulevard last month is recovering at Marin General Hospital in Greenbrae is improving.

Emma Simmons, 20, was on her way to her job as a cashier at a Novato gas station Wednesday, November 25 around 8 a.m. when he was hit by a vehicle traveling northbound on the busy thoroughfare as she walked eastbound in a marked crosswalk near Lark Court.

Meanwhile, family and friends have started an Internet account to help Simmons care for her young son and any extended medical care she may need. Simmons could be in a hospital bed for several more weeks.

"She must have walked across that intersection hundreds of times before," Johnson said. "It's been pretty amazing the amount of support we've gotten. It's really touching that there are so many good people in the world. The support has been amazing."
