

Road Repair and Accountability Act - Senate Bill 1

Senate Bill 1 (SB1), a landmark transportation funding package passed by the legislature in 2017, will invests \$54 billion over the next decade to fix local roads, highways and bridges in California communities. SB1 represents the biggest new state commitment to transportation solutions in more than 30 years. The transportation investment is generated by a combination of gas and diesel taxes and vehicle license fees that are estimated to cost an average vehicle owner less than 30¢ per day.

Prop 6 Threatens SB1 Funding

An initiative to repeal SB1 through a constitutional amendment will be on the November 2018 ballot as Proposition 6. If this proposition is successful, state funding for road repair projects in Marin will be slashed by nearly 50% with no plans for replacement funds.

LOCAL STREETS AND ROADS

The County of Marin and our Cities and Towns will receive approximately \$8 million annually from SB1. The following is a chart of existing gas tax revenues and the additional SB1 gas tax revenues by jurisdiction. Example of projects in Marin are San Rafael's resurfacing of Lucas Valley and Smith Ranch Road, Novato's Traffic Signal Upgrade Program and San Anselmo's San Francisco Blvd. Rehabilitation.
