SUBJECT:	Appointment to the Citizens' Oversight Committee (Action), Agenda Item No. 8b

### **RECOMMENDATION:**

The TAM Board accepts the nomination and appoints the following COC member and alternate to serve the remainder of the current four-year term until May 2021 representing the North Marin Planning Area seat on TAM's Citizens' Oversight Committee (COC).

- Member: Charley Vogt
- Alternate: Veda Florez

### **BACKGROUND:**

The COC oversees the Measure A 1/2-Cent Transportation Sales Tax and the Measure B \$10 Vehicle Registration Fee revenue and expenditure activities. As an independent functioning group, the COC assures that the voter approved Measure A Sales Tax and Measure B VRF Expenditure Plans are carried out accordingly. This Committee will also serve in the same role for the recent voter approved Measure AA Sales Tax. The COC is composed of 12 members and 12 alternates who are private citizens residing in Marin County and collectively represent the diversity of Marin County. All COC members should have no economic interest in TAM's projects. Over the years, due, in part, to the dedication and strong support of the members, the COC has become an indispensable part of TAM.

### **DISCUSSION/ANALYSIS:**

Ms. V-Anne Chernock, member representing the Northern Marin Planning Area, was first appointed to the COC in October 2011 and served on the Committee until May 2018, when her family moved out of Marin County. Staff has reached out to various community groups to solicit interested parties to serve the Northern Marin Planning Area seat since the departure of Ms. Chernock. Staff was grateful to receive the applications from Mr. Charley Vogt and Ms. Veda Florez.

Mr. Vogt is very interested in supporting TAM. As a senior manager in both private banking and municipal government, Mr. Vogt has the broad range of experience, education and desire to serve on the COC and assist TAM staff with the financial oversight and promotion/education of various critical transportation projects/programs in Marin.

Ms. Florez is a long-time resident from Novato. She has been focusing on various transportation issues in the County and the Bay Area for many years and is also very interested in being on the TAM COC. She serves on the Policy Advisory Council of the Metropolitan Transportation Authority, representing the Minority Community of Marin and is a regular bus user.

In accordance with the TAM Transportation Sales Tax Expenditure Plan which requires that each organization must nominate its representative prior to the final appointment made by the TAM Board, Board members representing the Northern Marin Planning Area reviewed the applications from both applicants and recommend appointing Mr. Vogt as the member and Ms. Florez as the alternate for the Northern Marin Planning Area. The current term for the seat will expire on May 31, 2021.
