# Recap of SWG #3 and Team Activities

#### What We Heard at SWG 3

#### SWG Comments on Bike/Pedestrian Options

- Directional protected bikeways on Bellam were preferred by SWG members.
- Option 3, new bike/pedestrian overcrossing of I-580, should not be developed further.
- Consider pedestrian safety and bike/pedestrian connectivity to CalPark path, Davidson Middle School, and other local improvements (e.g., West Francisco Blvd.)
- Additional information should be developed on pedestrian and bike counts, origins, and destinations; pedestrian safety; intersections; turning lanes; driveway access; and landscaping.

#### SWG Comments on Connector Alternatives

- Consider people/equity issues when evaluating alternatives, including access and connectivity, water and air quality, traffic flow, and cultural impacts.
- Provide additional information on origins and destinations, travel times, and traffic impacts.
- Closing the eastbound 580 offramp at Bellam is undesirable (Alternatives 3B and 4).
- Alternatives 2, 4, and 5 have impacts to business properties and high structures.
- Alternatives 3A and 3B could cause visual and air quality impacts nearer to the community.

# SWG Equity Considerations from SWG 3

- Look at project from perspective of people and users
- Improve access, including emergency access
- Reduce pollution
- Improve connectivity, including to Cal Park path
- Improve crossings for peds/bikes
- Improve safety
- Add greenery
- Eliminating parking is bad
- Don't want new/more structures separating community

#### What We Heard on Equity Issues

#### The Canal Area

- The heart of Marin's Latinx community. Culturally rich.
- Immigrants from throughout Latin America, particularly Mexico, Guatemala, and El Salvador.
- Also home to Vietnamese immigrants, African-Americans, and Caucasians.

#### Challenges

- Lower family incomes, higher health disparities, lower life expectancy, and lower school performance compared to County averages.
- 80% of Marin COVID cases in the Canal. Severe rent crisis as a result of pandemic.
- Highly vulnerable to sea level rise and climate change.
- Strong sense of community and workforce exploitation by Marin residents and businesses.

#### Access

- Isolated from the rest of San Rafael. Need better access in and out of the Canal.
- Difficult access to San Pedro School and San Rafael High School.

#### **Transit**

- Local transit lines are good. Marin Transit engaged residents.
- Countywide access is poor due to multiple transfers and limited service.

#### What We Heard on Equity Issues

#### Community Needs & Opportunities

- Community-wide access to wi-fi and fiber optic (SMART corridor)
- Meeting spaces near residential areas.
- Residential parking near multi-family properties.
- Job training and employment opportunities.
- Bellam Boulevard safety for people, not only bicycles.

#### **Related Planning Activities**

- Resilient by Design Challenge (2018) Sea level rise adaptation
- General Plan update (2021).
- Priority Development Area (PDA) grant (2021).

#### **Engagement**

- Residents need context to understand alternatives.
- Culturally appropriate facilitated workshops







Existing Land Use | NB 101 to EB I-580 Direct Connector Project Proposed Study Area


#### Cultural


- •26-40% of Canal District residents live in poverty
