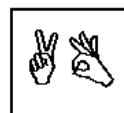
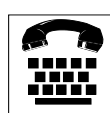

(In order to ensure staff receives your comment during the meeting, it is recommended that you send your comment early in the meeting.)

If participating by phone, "raise hand" on Zoom by pressing *9 and wait to be called on by the Chair or the Clerk to speak. Ensure that you are in a quiet environment with no background noise.
