




#### Reduce congestion on US 101 and local streets

#### **SWG Comments on Connector Alternatives**

- Consider people/equity issues when evaluating alternatives, including access and connectivity, water and air quality, traffic congestion, visual, and cultural impacts.
- Provide additional information on origins and destinations, travel times, and traffic impacts.
- Do not limit access for any of the surrounding communities, coordinate with ongoing planning efforts
- Travel times into the Canal Neighborhood should not be negatively impacted by the project.
- Minimize property impacts

#### SWG Comments on Bike/Pedestrian Options

- Safety enhancements of pedestrian/bicycle access between north and south sides of 101 and 580.
- Bike/pedestrian connectivity to CalPark path, Davidson Middle School, transit hubs, and other local improvements (e.g., West Francisco Blvd.)
- Additional information should be developed on pedestrian and bike counts, origins, and destinations; pedestrian safety; intersections; turning lanes; driveway access; and landscaping.

#### SWG Comments on Community Engagement and Outreach

- Consider and include perspectives from the Canal Neighborhood along Woodland Avenue, the Montecito Neighborhood, and other low income and minority areas
- Communicate that the connector alternatives and Bellam corridor improvements are apart of the same project.
- Bi- or Tri-Lingual Outreach Materials (English/Spanish/Vietnamese)

#### **SWG Comments on Equity**

- Consider people/equity issues, including access and connectivity, water and air quality, traffic congestion, visual, and cultural impacts.
- Provide additional information on origins and destinations, travel times, and traffic impacts.
- Consider opportunities for promoting economic development, job opportunities, and avoidance of blighted parcels in the project area.

#### **Updates Since Last SWG Meeting**

- Project name changed to reframe goals and objectives of the project
- Alternatives 2, 3A, 3B (Modified), and 6 selected to advance to the environmental phase
  - Continued refinement of alternatives for geometry approval
- Completion of Caltrans Planning Document (PSR-PDS)
  - Document Signed September 7, 2023
- On-going development of Bellam Corridor Improvements, incorporating bike/ped enhancements

#### **Updates since last SWG Meeting**

- Initiated preliminary traffic studies
  - On-going effort to be completed in the environmental clearance phase.
- Continued Community Outreach
  - Community Capacity Building for Spanish-Speaking community started
    September 2023
- > Beginning of Environmental clearance phase of the project
  - Expected Scoping meeting Early 2024



#### **Project Goals and Objectives**


- Enhance circulation on local streets by separating regional passthrough traffic from local traffic on surface streets and provide reliable travel times for regional and local traffic.
- Enhance the active transportation network (e.g. bicycle, pedestrian, bus transit) within the project area and improve connectivity to transit hubs in San Rafael, Larkspur, Richmond, and El Cerrito.
- Enhance bicycle and pedestrian safety on local streets by constructing protected bike lanes and rerouting regional traffic that contribute additional risk and stress to bicyclists, pedestrians, and other vulnerable road users;
- Improve connectivity between NB US 101 and EB I-580 for regional traffic in and out of Marin County using the Richmond-San Rafael Bridge
- Enhance and support economic prosperity in the project area by providing better and more reliable access to current and future businesses




#### **Alternative 2 – Simms St**



#### Alternative 3A - "Low Speed A"




#### **Alternative 3B (Modified) with New Bellam Exit**




