May is Bike Month!




May 7th – Bike to School Day

Redwood Bikeshare Program Update

Expanding E-Bike Fleet – Since October 2024, 262 e-bikes have been deployed across Marin and Sonoma, with 300 total planned by May

Growing Usage – System hit a record 750 trips in April




E-Bike Safety – Public Education Campaign & AB 1778

- Marin County Special Committee on Youth E-bike Safety formed in response to safety data
- Educational campaign
 - Campaign launch prior to end of current school year (May) and continue during back-to-school period (Aug/Sept)
 - Complementary to Safe Routes to Schools education/messaging
- AB 1778: 2024 state legislation allows a Marin pilot to restrict Class 2 e-bikes to 16 & over
 - Goal to have countywide adoption by summer
 - County and cities/towns considering ordinances

Project Overview

This awareness campaign aims to raise the visibility and understanding of E-Bike safety in the County of Marin. This initiative aims to educate and engage kids and families on buying legal and local, safe riding, and how to pick the right E-Bike. The campaign will focus on local exposure to County of Marin residents.

FY25/26 Measure AA Funds for Local Infrastructure

- Measure AA allocates 22% of funds to Category 2.1 for maintaining safe, wellmanaged streets for all users
- Funding amounts have been shared with Public Works Directors
- Agencies will submit project allocation requests in May 2025; approvals at the June/July TAM Board meeting



Measure AA – Innovation Program

- Funded from Local Roads Category: 0.5% (~\$150K/yr)
- Used for Quick Build projects during the pandemic
- ~\$730k potentially available for a Call for Projects through FY25/26
- Four potential focus areas to deliver on CTP goals and strategies:
 - 1. Modernization of Traffic Signals 2025 study funded by MTC
 - 2. Active Transportation Focus new technology
 - 3. Community Mobility Innovations capital funding for specific needs
 - Climate/Environmental Pilots examples: "cool" streets, green streets, fire evacuation







SMART Updates

SMART Connect Larkspur Shuttle Expansion



- Pilot extended an additional year with service expansion to 7 days per week
- Expanded service aligns with the San Francisco Giants season, helping fans travel via SMART train and Golden Gate Ferry
